

Summary of Appeals -- August 4, 2016

(updated 7-25-16)

9:15 – 9:30 **The Alignment Committee previously heard and approved the following appeals on January 13th and by email votes:**

Recommend voting on these as a group rather than individually.

Atlee – Move from 5A North Region to 5A Central Region. There would be no change in district (Capital).

NOTE: Patrick Henry (Ashland) presented the same appeal in January and received approval, but their ADM numbers moved them down to 4A.

Auburn – move from the Three Rivers District to the Mountain Empire District.

Carroll County – Move from River Ridge District to the Three Rivers District.

Graham – Move from the Mountain Empire District to the Southwest District.

Marion – Move from the Hogoheegee District to the Southwest District.

Narrows – Move from the Mountain Empire District to the Pioneer District.

Rockbridge – Move from the Blue Ridge District to the Valley District.

Rural Retreat – Move from the Hogoheegee District to the Mountain Empire District.

George Wythe (W) Move from the Hogoheegee District to the Mountain Empire District.

9:30 – 9:40 **Sherando:** Requests to remain in North Region, 4A Classification rather than their 5A Classification where the March 31, 2016 ADM numbers place them.

9:40 – 9:50 **Alleghany:** Requests to be placed in 2A classification rather than 3A classification where the March 31, 2016 ADM numbers place them; move from Region 3A West to Region 2A Central and move from Blue Ridge District to the Three Rivers District.

9:50 – 10:00 **Bassett:** Requests to be placed in 3A Classification rather than 4A Classification where the March 31, 2016 ADM numbers place them.

10:00 – 10:10 **Christiansburg:** Requests to move from the River Ridge District to the Three Rivers District.

10:10 – 10:20 **George Marshall:** Requests to move into Region 4, 6A Classification and request to remain in their current district.

10:20 – 10:30 **Abingdon:** Requests to move from Southwest District to Mountain District.

10:30 – 10:40 Grayson County: Requests to remain in the Mountain Empire District after previously being approved to move to Southwest District.

10:40 – 10:50 JEB Stuart: Requests to be placed in Region 3, 6A Classification and to remain in their current district, National District.

10:50 – 11:00 Loudoun County Schools: (Heritage (LC), Rock Ridge, Riverside, Freedom and Loudoun Valley): Several Loudoun County Schools have requested that for the 2017-18 and 2018-19 alignment cycle, district alignment be determined by each school's classification, placing all 4A schools in the Dulles District and all 5A schools in the Potomac District. The Loudoun County administration approves this concept and has provided a letter supporting this for the all school in Loudoun County.

11:00 – 11:10 Eastern View: Requests to remain in 4A Central Region as originally assigned and be placed in the Battlefield District.

NOTE: Eastern View originally request to move to 4A West and the request was tabled.

11:10 – 11:20 Nelson County: Requests to be moved from the 2A Northern Region and be assigned to the Central Region since their request to join Shenandoah District was denied thus they will remain in the Dogwood District.

11:20 – 11:30 Northwestern District: The principals of the Northwestern District request the formation of a 13-team district to include the following schools:
