- Home School passed both the House and Senate:
  - Gov. plans on veto (2<sup>nd</sup> straight year)
- House Bill 965
  - Give 6 votes to 6A schools
  - Tabled until next year
- Interviews for Ken Tilley's position moving forward (2/10)
- April 20<sup>th</sup> is Ken Tilley's luncheon
- State Event Sites
  - Met in Dec. w/ colleges and interest groups
  - Should be approved in May
- Reviewed Executive 1<sup>st</sup> Vote Items (handout given)
- Ejection of player/coach (1st vote item) 27-11-6
  - Motion to accept 27-11-6 1<sup>st</sup> Kettle Run, 2<sup>nd</sup> John Champe- add language for 3 consequences later
    - Concern over equity for all sports---by adding 90 school days
